Entry restrictions:	<p>An entrant must be (“Eligible Entrant”):</p> <ul style="list-style-type: none"> <li>• a resident of Australia or New Zealand or hold a valid visa for full time study, apprenticeship or work rights</li> <li>• aged 18 years or over as at 1 February 2026;</li> <li>• either an apprentice cook or enrolled in a government recognised cooking or patisserie course; and</li> <li>• graduating or have graduated from a recognised cooking or patisserie course in Australia or New Zealand the year of application (in this instance, 2025).</li> </ul> <p>Employees of the Promoter (and their immediate families) or its related companies in Australia or New Zealand, and agencies associated with this competition are ineligible to enter. Selection of finalists:	<ul style="list-style-type: none"> <li>• Up to 32 finalists ("Finalist") will be selected by a judging panel appointed by the Promoter ("Judging Panel"), based on their original recipe, responses to questions and if required, verbal interviews with the Competition's Culinary Educator or other person nominated by the Promoter.</li> <li>• Finalists will be given the opportunity to attend the program in Melbourne ("Melbourne Event") between 1 February 2026 and 4 February 2026 (or other dates as may be advised by the Promoter). The Melbourne Event may be cancelled or rescheduled for reasons or circumstances outside of the control of the Promoter.</li> <li>• At the Melbourne Event, Finalists will take part in Master Classes with chefs, dine at the Mentor Chef's or recommended restaurant, and participate in a cook-off on the final day.</li> <li>• The Melbourne Event includes: <ul style="list-style-type: none"> <li>- a return economy class airfare from the Finalist's Australian or New Zealand capital city/closest airport to Melbourne airport (if required);</li> <li>- airport transfers within Melbourne and competition-related transport in Melbourne;</li> <li>- set meals from breakfast on 1 February 2026 through to breakfast on 5 February 2026;</li> </ul> </li> </ul>

Their aptitude will be judged by the Judging Panel based on observations of the Finalists, comments made by the Master Class hosts and participation in the industry networking sessions.
